CHILD WAIVER AND RELEASE OF LIABILITY FOR PARTICIPATION IN FIREARMS OR ARCHERY ACTIVITIES AT G2G FAMILY SHOOTING AND ARCHERY, LLC

I, and/or _____ (hereinafter referred to as "CHILD") the undersigned and identified persons, desire to participate in firearms usage (including all firearms, specifically including BB Guns, pellet guns, AirSoft rifles, etc.) and or archery activity at the G2G Family Shooting & Archery, LLC ("Shooting/Archery Facility") being conducted and administered by G2G Family Shooting & Archery, LLC, or any other person or entity providing a place to engage in Shooting/Archery Facility activities. As an essential component of my and/or CHILD's consideration to participate in the activities included in and surrounding the Shooting/Archery Facility, I hereby enter into and agree to be bound by the terms of this Waiver And Release Of Liability For Participation In Firearms or Archery Activities At the Shooting/Archery Facility, for myself, CHILD, and my and CHILD's assigns, heirs, next of kin, or estate. I HEREBY ACKNOWLEDGE UNDERSTAND AND AGREE TO THE FOLLOWING:

1. I fully understand that I and/or CHILD, and other individuals will have access to and must handle firearms, ammunition or archery equipment at the Shooting/Archery Facility. I further acknowledge that handling firearms, using firearms and using archery equipment can INVOLVE RISK AND DANGERS of serious bodily harm, serious bodily injury, including DEATH. I fully understand these risks and dangers may be caused by my own and/or CHILD's actions, or my own and/or CHILD's inactions, omissions, the actions or inactions of other participants at the Shooting/Archery Facility, the conditions in which the handling of firearms and archery activity takes place (including but not limited to the firing range and its equipment and other firearms facilities or equipment or those used in archery), and/or the negligence of the released named above. Specifically at risk due to exposure to lead, gunpowder and/or the concussive effects of discharging firearms are individuals with certain medical conditions such as heart related illnesses, hearing and vision issues, hypertension, pregnancy, and nervous disorders. I hereby FULLY ACCEPT AND ASSUME ALL SUCH RESPONSIBILITY FOR THE RISKS DESCRIBED ABOVE while a participant in the Shooting/Archery Facility.

2. I Agree and Warrant that I will examine and inspect each activity or piece of equipment at the Shooting/Archery Facility on for myself and on behalf of CHILD (including but not limited to firearms, ammunition, holsters, firing range, firing range equipment, hearing protection, eye protection, any archery equipment or any other equipment of what so ever kind used in the Shooting/Archery Facility). I hereby FULLY ACCEPT AND ASSUME ALL RESPONSIBILITY FOR THE RISKS of using any facility or equipment used at the Shooting/Archery Facility, regardless of the origin or ownership of the equipment. If I observe any activity or equipment I consider to be hazardous or potential harmful to myself, CHILD, or others, I will notify an employee of the Shooting/Archery Facility immediately and I and/or CHILD will refuse to take part in any activities I consider unsafe until the condition has been corrected to my satisfaction.

3. I HEREBY VOLUNTARILY AFFIRM AND AGREE that I FULLY WAIVE, RELEASE, INDEMNIFY, HOLD HARMLESS, on behalf of myself and CHILD, G2G Family Shooting & Archery, LLC, or any other person or entity providing a place or service to engage in Shooting/Archery Facility activities, and their or its owners, employees, managers, officers, agents, assigns, and their contracted entities involved with the Shooting/Archery Facility, from any and all liability, claims, demands, actions, rights of action, cause of action, or legal proceeding whatsoever, whether personal to me and/or CHILD or to a third person should I and/or CHILD become injured from whatsoever cause (whether physically, financially, or emotionally) or cause injury to others while I and/or CHILD are involved in activities at the Shooting/Archery Facility, or coming or going to any activity at the Shooting/Archery Facility. I further FULLY WAIVE, RELEASE, INDEMNIFY, HOLD HARMLESS and DISCHARGE, on behalf of myself and CHILD, G2G Family & Archery Facility, or any other person or entity providing a place or service to engage in Shooting/Archery activities, and their, or, its owners, employees, managers, officers, agents, assigns, and their contracted entities involved at the Shooting/Archery Facility, from any and all liability, claims, demands, actions, rights of action, cause of action, or legal

proceeding whatsoever, whether personal to me and/or child, or to a third person based upon any injury that may be claimed, by me and/or CHILD or any other person, to have arisen out of the undersigned participation in any activities at the Shooting/Archery Facility or anything that the undersigned may have been done, taught, learned, not taught, or did not learn, at the Shooting/Archery Facility.

4. Further, I ACCEPT AND ASSUME ALL RISK AND RESPONSIBILITY, on behalf of myself and CHILD, from the use of any borrowed, rented, or loaned firearm(s) or any archery equipment rented, or loaned to me and/or CHILD that I and/or CHILD may use at the Shooting/Archery Facility. It is my duty to inspect any such firearm(s) or archery equipment for proper functioning for myself and/or on behalf of CHILD prior to my and/or CHILD's use of any such firearm(s). I FULLY WAIVE, RELEASE, INDEMNIFY, HOLD HARMLESS AND DISCHARGE, on behalf of myself and CHILD, G2G Family Shooting & Archery, LLC, or any other person or entity providing a place or service to engage in Shooting/Archery Facility activities, and their, or, its owners, employees, managers, officers, agents, assigns, and their contracted entities involved with the Shooting/Archery Facility, from any and all liability, claims, demands, actions, rights of action, cause of action, or legal proceeding whatsoever, whether personal to me and/or CHILD or to a third person should I and/or CHILD become injured from whatsoever cause (whether physically, financially, or emotionally) or cause injury to others while using a borrowed, rented, or loaned firearm(s) or archery equipment while I and/or CHILD are involved in activities at the Shooting/Archery Facility, or coming or going to any activity at the Shooting/Archery Facility.

5. I acknowledge, affirm, and agree that I have had sufficient opportunity to read this entire WAIVER and RELEASE of my and/or CHILD's rights, that I understand its content, and that it is legally binding, and that I executed it freely without duress of any nature, and intend this document to be a complete and unconditional release of all liability to the greatest extent of the law and agree that if any portion of this agreement is held invalid, the balance shall continue in full force and effect. I represent that I have the legal capacity to execute this document on child's behalf. I acknowledge that G2G Family Shooting & Archery, LLC would not allow me or CHILD access to any of its facilities or equipment if I do not have the legal ability and capacity to act on behalf of CHILD and execute this document on CHILD's behalf.
